Abstract: The collection comprises architectural drawings and photoprints (of graphics),

documenting 65 projects designed between 1963-1989 by the firm of Wallace, McHarg,

Roberts, and Todd and its successor firm, Wallace, Roberts, and Todd.

# Biographical/Historical Sketch

Thomas A. Todd was born in 1928 in North Stonington, Connecticut. He graduated from Haverford College (B.A. 1950) and the University of Pennsylvania (B. Arch. with honors and M.C.P., 1959). In 1963 he became a partner in Wallace-McHarg Associates, and in 1964 the partnership became Wallace, McHarg, Roberts, and Todd. The partners, David A. Wallace (b. 1917), Ian L. McHarg (1920-2001), William H. Roberts (b. 1932), and Todd brought together skills of different disciplines (architecture, landscape architecture, urban planning and ecological studies) to form a firm best known for city planning and urban design. In 1980, after the departure of Ian McHarg, the firm was renamed Wallace, Roberts, and Todd.

The firm's early success in designing the Baltimore Inner Harbor (1963-1979) was followed by urban design studies for many other United States cities, including its collaboration with Mitchell/Giurgola on the United States Capitol Master Plan (1977-1981). The firm gained international recognition with its plan for Abuja, the new capital of Nigeria (1979-1986).

# Scope and Content Note

The collection comprises 661 sheets of architectural drawings and two photoprints (of graphics), documenting sixty-five projects designed between 1963 and 1989 by the firm Wallace, McHarg, Roberts, and Todd, its predecessor firm Wallace-McHarg Associates and its successor firm, Wallace, Roberts, and Todd.

The bulk of the collection comprises rendered presentation drawings delineated by Todd. Many of the firm's major planning, civic, commercial, and residential projects are represented in the collection including the firm's master plan for the U.S. Capitol. Projects particularly well documented include the Baltimore - Inner Harbor Master Plan and the Nigerian Federal Capitol Master Plan. Neither the plan of the Valleys (Baltimore 1963) nor the Pardisan project (Tehran, Iran 1975) is represented.

The collection contains no reports, office files, or photography of built works.

The collection is arranged in three series according to storage requirements:

- I. Architectural Drawings.
- II. Architectural Drawings large format, flat.
- III. Architectural Drawings large format, rolled.

All three series are arranged in alphabetical order using short project names devised by the Architectural Archives. In most cases, a project for a personal client is named using the surname of the client, e.g., Johnson House.

Note about additional materials received January 2007

On 1/18/2007 Tom Todd met scholar Nnamdi Elleh at the Architectural Archives to assist him in the revision of his book: *Abuja: the Single Most Ambitious Urban Design Project of the 20th century.* Weimar: VDG, c2001.. (Fine Arts Library HT169.N62 A287 2001).

On this occasion, Todd arranged for the Archives to receive a copy of "The Master plan for Abuja the New Federal Capital of Nigeria," a report produced by International Planning Associates (IPA) (including Todd) and the Federal Capital Development Authority in 1979.

Todd also asked the Archives to photocopy a 1978 report "Initial Logistics Plan" (referred to on page 264 of the Master Plan), of which only one copy was known to have survived. One photocopy was presented to Nnamdi Elleh and a second was retained by the Architectural Archives. This report reflects the awareness of IPA that previous efforts at modernization had been halted by the lack of transportation, construction and management infrastructure. The report provided step by step plans for providing the infrastructure required for timely completion of the city.
