Abstract: This collection is the primary archive of the architectural work of Richard A. Yarnall.

The bulk of the collection comprises architectural drawings and photoprints

documenting 176 projects spanning the years 1956-2000. The collection includes 36 of

his student drawings from the University of Pennsylvania, dated 1946-1948.

## Biographical/Historical Sketch

Richard Yarnall was born in Philadelphia in 1922 and graduated from Germantown Friends School before enrolling in Colgate University, completing a B. A. there in 1946. He studied architecture at the University of Pennsylvania, earning a B. Arch. in 1949. After completing his architecture degree, Yarnall worked for Philadelphia firms: Carroll, Grisdale & Van Alen (1949-1954), and then Wright, Andrade & Amenta (1954-1957). He was general manager for the Roberts Construction firm in 1952-1953. In 1957, he opened his own architectural office in Philadelphia. He moved his practice to Doylestown in 1972 and retired in 2001. Yarnall's practice included a large number of residential projects, together with a smaller number of commercial and institutional projects. His work focused in the greater Philadelphia region of Pennsylvania, New Jersey and Delaware.

## Scope and Content Note

This collection is the primary archive of the architectural work of Richard A. Yarnall. The bulk of the collection comprises architectural drawings and photoprints documenting 176 projects spanning the years 1956-2000. The collection contains no substantial office or project files; minor office records are found for a few projects. A job list drawn up by the architect is found at call # 111.74. The collection includes a selection of thirty-six of his student architectural drawings from the University of Pennsylvania, dated 1946-1948.

The collection is arranged in three series:

- I. Architectural Drawings.
  - A. Project-related Architectural Drawings
  - B. Student Drawings
- II. Photographs and Clippings.
- III. Miscellaneous Materials.

All three series are arranged in alphabetical order by client's last name.
