- Perform data entry into LCP Tracker on an as-needed basis. Be comfortable with the complete navigation of LCP Tracker.
- Be able to organize data, file paperwork and use Microsoft Excel and Microsoft Suite to complete reports as needed.
- Submit Certified Payroll Reports to 3rd party data verifiers in a timely and organized manner.
- Keep track of Change Orders on projects as it pertains to OEO compliance.
- Be able to analyze detailed Pay Applications for any project assigned.
- Complete OEO reports to be presented to upper management and/or 3rd party verifiers such as Municipal and County Officials.



- Create subcontractor-specific plans to facilitate accomplishment of EOP goals. Be able to engage with contractors and subcontractors in an effective manner and be able to deliver positive results for the project.
- Meet with Owners, GCs, CMs and subcontractors on an as-needed basis to discuss project goals and their contribution to these goals.
- Meet with Owners, Institutions, GCs, CMs and market our services.
- Be knowledgeable of Section 3 Reporting requirements and be able to complete all necessary reporting to appropriate parties.
- Meet with necessary project personal to discuss Certified Payroll Compliance, OEO Compliance, and Section 3 Compliance.

- Work with Senior Management to achieve goals of organization.
