## 2019 PWRful Design Scholarship Application Terms and Conditions

This document outlines the Terms and Conditions for the 2019 PWRful Design Scholarship administered by Professional Women's Roundtable (PWR). By submitting an application for our academic scholarship, you are agreeing to these Terms and Conditions. You must read these Terms and Conditions in their entirety before you submit your application.

All correspondence between student applicants and PWR will be operated primarily via email and telephone communication, with the option of in-person interviews based on PWR's decision. All student applicants must use a university or college email address to be eligible. Any changes to this email address, after submission of application and without necessary cause, may result in cancellation of their application.

The student recipient of this academic scholarship may also be required to sign an individual scholarship agreement outlining the allowed expenditure. The student recipient must meet all the conditions as outlined in the agreement.

The student recipient will be required to show proof that they are enrolled in an accredited U.S. college or university in the Greater Philadelphia region, commencing studies for the fall semester 2019.

The student recipient will receive an official "offer" email and must reply either accepting or rejecting this offer within 7 days of receipt. Failure to respond within this 7-day period may result in the scholarship offer being withdrawn and reassigned. The student recipient must accept the offer by the due date, as instructed in the offer email, to be eligible to receive payment.

PWR will make payment of the academic scholarship fund in one single installment, though PWR reserves the right to make payment in multiple installments, as seen fit. The total value of the scholarship offered is \$1000.

The academic scholarship fund may be paid into your nominated bank account, to your college or university, or by other means, to be discussed between PWR and the student recipient. PWR reserves the right to make the final decision on how payment is made, and can withdraw the offer of scholarship if an amicable and realistic payment process cannot be reached.

This scholarship will be awarded based on established eligibility criteria. Student applicants must be a woman identifying college student currently enrolled full-time at an accredited U.S. vocational, junior college, or four-year college or university in the Greater Philadelphia area. Applicants must be a full-time, degree-seeking student during the 2019-2020 academic calendar year and pursuing a major in Computer Graphics, Computer Programming, Design and Visual Communications, Digital Arts, Graphic Design, Information Science, Studio Arts, or Web Development. Applicants must be 18 or older. The student recipient must meet these eligibility requirements to receive the scholarship payment.

PWR is not responsible for and cannot provide financial advice on taxation matters. PWR is not responsible for checking and notifying the student recipient of, nor paying any taxation obligations.

Providing false or misleading information is an offence.
