Introduction

This course explores the intersection between historic preservation, design and public policy, as it exists, as it is evolving, and, inevitably, as it needs to evolve. That exploration is based on the recognition that a challenging and challenged network of law and policy at the federal, state and local level has direct and profound impact on the ability to manage cultural resources, and that the pieces of that network, while interconnected, are not necessarily mutually supportive -- let alone not as responsive as they might be. The fundamental assumption of the course is that the preservation professional must understand the capabilities, deficiencies, and ongoing evolution of this network in order to be effective. The course will look at a range of relevant and exemplary laws and policies existing at all levels of government, examining them through case studies and in-depth analyses of pertinent programs and agencies at the local, state and federal level. The course aspires to enabling students to understand the range of preservation policy well enough to consider specific enlargement of its reach and outcomes.

Course Format

The class will utilize Canvas (the University's Learning Management System) for overall organization, communications and other interactions – assignments, discussions, readings, etc. Readings that are indicated as a website link in the syllabus below are of course directly available through that URL. Those that are indicated without a URL will be distributed via Canvas. Mr. Hollenberg will also provide through Canvas a one-page weekly overview of the readings, indicating which have priority, which need to be read carefully versus those that can be skimmed, etc. (Note: information about the readings in the syllabus marked "access TBD" will be provided when determined.)

On at least three occasions throughout the semester students will be asked to have in-depth discussions with each other about the course content, especially with regard to considering both the roots of policies under consideration and to exploring their possible enrichment.

In addition, throughout the semester, each student will have a minimum of two individual sessions with Mr. Hollenberg, in-person or via Zoom, to discuss understanding of the course content. These individual meetings will be scheduled when the semester starts. Additional office hours will of course be available, on request, at a mutually agreeable time.



Course Requirements and Grading

University regulations require that students in this course be graded (A=excellent, B=good, C=average, F=failing). Grades will be based on the criteria and course requirements summarized below.

- Attendance, completion of the weekly readings, and participation in class discussion. (33% of grade). All students, are expected to come to class having read the assigned material and be prepared to discuss it.
- Performance on special assignments and/or periodic and unannounced short quizzes, no more than 8 and no less than 4 throughout the semester. Individual or group presentations, with attendance and participation of each student **required**, will be part of several class sessions (Class # 7, 10, 11 and 14), and will count as one of these quizzes. Up to four of the remaining quizzes will typically involve an essay question, and may address assigned readings for the week, before they have been discussed in class. Others will involve the reports from the small group "break-out" sessions described above. In each case, quizzes and "break-out" reports will be judged on completeness of information, clarity of thought, and logic of organization. (33% of grade)
- Performance on the Final Examination, which will consist of essay question(s) about broad issues that encompass the entire semester. (33% of grade)

Quiz and exam grades are calculated according to a sliding (rather than absolute) scale. It would thus be possible, in theory, for everyone in the class to get an A, although ordinarily about half or fewer receive an A+, A, or A-, about half or fewer receive a B+, B, or B-; and a very few receive C+, C, or C-. Sometimes a very, very few receive a D or an F. Because of the sliding scale, if everyone fails to answer a particular part of any examination, nobody is penalized (and the instructor notes a personal shortcoming). On those few occasions when a student receives an F for one of the mid-term quizzes, but receives a B or higher for the others and the final, the single F is discounted in calculating the course grade.
